JoAnn L. Smith, born and raised in Hawaii, currently serves as the Lead Pastor of Pleasant View Deaf Assembly and as Department Chair for the Carlstrom Deaf Studies of North Central University. She is the wife of Pastor Rod and the mother of two adopted Deaf sons from the country of Estonia (Andrei is 29 and Juri is 23).

Her ministry includes 13 years as a National Appointed Home Missionary, 10 of those years – she was a Campus Pastor at National Technical Institute for the Deaf (1977-1978); Campus Chaplain at Gallaudet University (1981 – 1991); professor at Central Bible College; the Minnesota A/G District Representative for Deaf Ministries; and the National Deaf Fellowship North Central Regional Representative. She has an earned doctorate (2005) from Regent University in the field of Organizational Leadership – focusing on the natural election of Deaf leaders.

## From the South

North on 35W to 11th Street./Grant Street exit. Take E. Grant St. & follow to 14th St. Turn right on Chicago Ave. and turn right right-away to parking lot near Bookstore.

## From the East

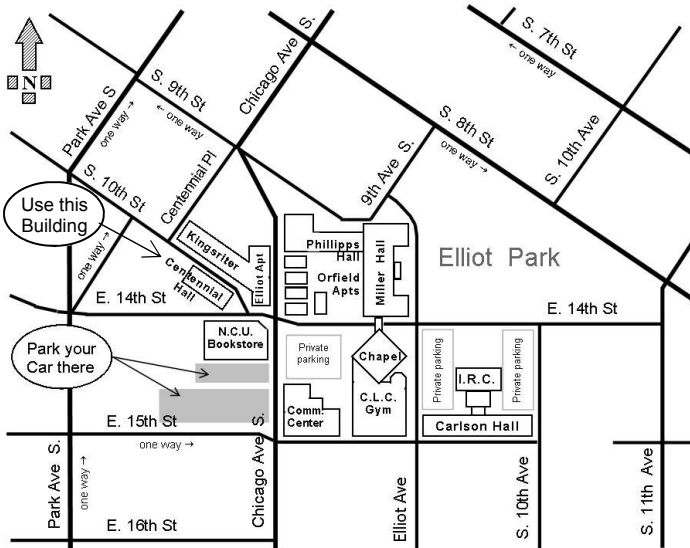
West on 94. Take the 5th Street exit. This will bring you to 11th Ave. Go left on 11th Ave. Proceed to 14th St. E. & take a right. Turn left on Chicago Ave and turn right right-away to parking lot near Bookstore.

## From the North

South on 35W. Take the 11th Ave. Exit. Get on 11th Ave. south, Turn right on 14th St. E. then to turn left on Chicago Ave and turn right right-away to parking lot near Bookstore.

## From the West

East on 94. Take the 4th Street Exit. Proceed on 4th Street to Kirby Puckett Place/Chicago Avenue, and turn right. Take Kirby Puckett Place/Chicago Avenue (stay on Chicago Ave. S), go pass 14th Street E., turn right right-away to parking lot near Bookstore. (OR) East on 394 to downtown exits. Continue to 4th Street ramp. Proceed on 4th Street to Kirby Puckett Place/Chicago Ave. and turn right. Take Kirby Puckett Place/Chicago Ave. (stay on Chicago Ave. S), go pass 14th Street E., turn right right-away to parking lot near Bookstore.



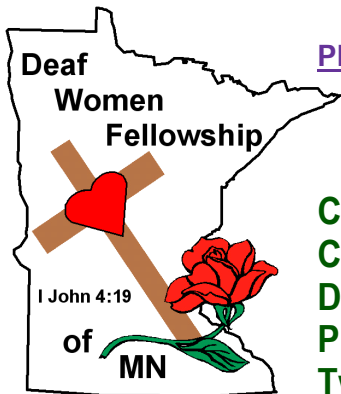
